Dear Ms. Bond,

I am a creditor of Mr. Erwin Singh Braich in the above noted file.

In my capacity as the Deputy Registrar and an investigator with the College of Dental Surgeons for British Columbia I have much experience in dealing with legal matters, and by virtue of the fact of having been involved in the above noted proceedings for in excess of 13 years, I have become well versed in Bankruptcy and Insolvency law in Canada.

I have also represented myself in The Supreme Court of British Columbia, in my capacity as a creditor in the above noted proceedings and in my capacity as a representative of other creditors. In each of these proceedings I have lost more and more respect for the legal system in British Columbia.

I watched helplessly, and was in utter shock as the former Chief Justice of The Supreme Court of British Columbia (Donald Brenner), completely obliterated the Bankruptcy and Insolvency Act right before my very eyes. He literally legislated from the bench, and violated my rights as a creditor and citizen of this country over and over, as well as the rights of Mr. Braich.

This current round of persecution against Mr. Braich, (please see the end of this email for more details), by Crown prosecutor, Mr. Gerry Sair follows a long

running, and provable pattern by government agencies.

Mr. Gerry Sair is either voluntarily aiding and abetting one of the worst cover-ups in Canadian history, or being used as a pawn by those above him. Either way I write to request that the 'on again off again' Warrant that has been issued for the arrest of Mr. Erwin Singh Braich be immediately rescinded, or I myself in my personal capacity and the group of creditors that I represent, will be forced to also commence legal action against Mr. Gerry Sair, Ms. Wendy St. Onge, The Public Prosecution Service of Canada, the Royal Canadian Mounted Police, and likely the Offices of the Minister of Justice and the Attorney General.

Below is a link to a Declaration that I filed in the United States under penalty of perjury. I suggest it be read by yourself and/or someone that is quite senior at your offices.

The majority of the lawful creditors in this matter are fed up with certain members of the Canadian Government and the Judiciary. There is a clear pattern of these individuals repeatedly violating their oaths and committing despicable acts. Mr. Braich and the creditors have been injured over and over due to these malicious acts. This has been going on for an unfathomable 13+ years! I am aware of many acts that have been committed over, this time period, that are shocking to say the least. One of which was sending a Canadian Border Services Agent to pose as a writer who was interested in exposing this whole saga. She was paid and/or instructed by some government agent with taxpayers dollars to respond to an ad that was published in 2009. A copy of that ad can be viewed here:

The whole of the world seems to know the truth, as it stands in plain view, but for some reason the powers that be in this Province are always able to find someone to further assist them in their attempts to silence the truth, and persecution of an innocent man, and those that support him.

I write this letter at a complete loss as to how this all could have happened in a country such as Canada; a country I used to be proud of, to have been born in and which I currently choose to reside.

Being a Caucasian Canadian, even I can see that there is a clear bias against Mr. Braich due to the color of his skin, and his ethnicity being a Sikh Canadian. Had he not been a Sikh Canadian, it is my belief and of most all of my Caucasian friends,

that he would not have faced this level of persecution. It disgusts me when I review over in my mind what he has had to endure in the past 13+ years. Sadly it never seems to end, as evidenced by this latest round of tyranny. My friends, family, fellow creditors, and I are completely appalled at the behavior by some of those that hold the power in this country.

In the absence of a response from your offices, (truth be told none is expected at this stage), I will be calling my friends in the media, and letting the world know that I gave it one last attempt at contacting, yet another, Attorney General but to no avail.

It should be noted that over the years I have spoken to, and written to those that previously held your position, and they did nothing, so forgive me for thinking that your actions will differ from your predecessors.

I feel it important to also note that I was fortunate enough to have been chosen by my group of creditors to visit Bulgaria among other countries, and meet with Mr. Braich's management team to view hundreds of millions of dollars worth of assets. I ended up only visiting Bulgaria, a country where several hundred million dollars worth of Mr. Braich's assets were located. At that time I had to cut my trip short prior to visiting several other countries where Mr. Braich's assets were located. More about this trip is outlined in further detail in paragraph 17 of the Declaration (see below).

Please pay particular attention to paragraph 15, as we've dealt with this 'Warrant' nonsense before. It is unbelievable that we are here yet again. When is someone going to wake up, and do something about all of this?! How can this type of behavior be continuously repeated within the corridors of power?

It sickens me to think of how KPMG, who the creditors never even affirmed as trustee in the first place, is now doing all of what they are doing in the name of protecting us. KPMG, the very corporation that was supposed to protect the creditors, are the ones that have injured us the most.

It is tragic to see how KPMG helped hundreds of millions of dollars worth of assets to be frittered away in their attempts to cover up their wrongdoing. Further to this, KPMG, and now it appears the Government, continue to take directions

from the culpable parties. Many of these parties will be named as Defendants and questioned, under penalty of perjury, in the upcoming litigation that will be filed from the United States. This will be alongside the current Canadian based lawsuit Mr. Braich has already commenced. Now the Government, again under the guise of trying to protect us, is abusing their powers and processes to further aid and abet KPMG and others in their attempts to silence the truth. Simply astonishing!

What makes this story all the more unique, is that despite the hardships that were faced by Mr. Braich, he has yet again persevered, in a financial sense, and come out on top. The culpable parties should be ashamed of themselves for doing what they did.

As mentioned above I'm not holding my breath for a response, but rather I am writing this email to give your offices one last chance to voluntarily right a wrong that is a stain against this Government's already beleaguered reputation.

It is my belief, and that of a great many others, that if this matter is not dealt with swiftly and immediately corrected, it will become a full blown scandal of gargantuan proportions. You must be aware that a scandal of this proportion will surely be brought up prior to your re-election, by me, and my group of creditors, and many other concerned citizens. These concerned citizens are a diverse group who encompass many different minority groups. The majority of these citizens though are fed up Caucasian Canadians that have been watching this horrific series of events unfold from their various ridings, and now realize the levels to which the Government, KPMG, the RCMP, and others are willing to stoop to in order to cover their tracks.

I know of one Canadian creditor, (who happens to be a Sikh as well), who allegedly wrote one blog about this whole fiasco, that was actually arrested and charged under a draconian and rarely used law, which is technically still punishable by death in Canada!

During his interrogation he was threatened by KPMG, and told via the RCMP that he had 'target on his back'. More about this arrest can be read at these two links:

I feel at this point I should also mention, for your information, that I will be forwarding a copy of this letter to various parties around the globe.

Of course the current Opposition Critic for the Attorney General, Mr. Leonard Krog, will also be receiving a copy. I will also be forwarding a copy of this letter to appropriate people in the B.C. Conservative Party.

Along with the NDP, and BC Conservative Party, I will be forwarding a copy of this letter directly to Mr. Gerry Sair, Ms. Wendy St. Onge, Deputy Commissioner of the RCMP, the National Integrity Officer of the RCMP, and to the Prime Minister of Canada.

All tyranny eventually comes to an end. KPMG, and the government agencies that have been complicit in this cover up will have to face the truth, as the silent majority will now exercise their legal rights of Freedom of Speech, that are granted to us under the Charter of Rights and Freedoms in Canada. The rest of this saga will now unfold with the world's media watching.

I cannot urge you strongly enough that you, or the persons that you direct, review these materials from an unbiased point of view. Guard against being influenced by those who have something to lose by having this matter see the light of day.
